ARTICLES OF ASSEMBLY COVENANT (AAC)

1. Preamble

We, the undersigned living souls, by our free will and under the guidance of natural and divine law, do hereby enter into this Covenant as Members of the "Shield of Souls" Assembly (the "Assembly"), pledging our mutual honor, good faith, and unity in this sacred association.

2. Guiding Principles

- (a) **Sovereignty:** Each Member is a sovereign living soul, bearing inalienable rights and dignity bestowed by the Supreme Creator.
- **(b) Peace:** All Members are committed to the peaceful coexistence of the Assembly and the world at large.
- **(c) Honor & Integrity:** We pledge to act with truthfulness, fairness, and respect, upholding the integrity of the Assembly at all times.

3. Mutual Obligations

- (a) **Support:** Each Member shall support other Members in upholding their rights, resolving differences honorably, and maintaining Assembly unity.
- **(b) Privacy:** The affairs, deliberations, records, and identities within the Assembly shall be kept private, except where unanimous consent or specific Assembly process provides otherwise.
- **(c) Participation:** Each Member will participate in the life of the Assembly to the best of their ability, contributing to meetings, decisions, and community activities in good faith.

4. Commitment to Lawful Conduct

(a) Natural/Divine Law: The Assembly and its Members acknowledge only the supreme authority of natural and divine law in their relations.

(c) Peaceful Intention: Members agree to pursue all Assembly business and personal interactions without harm, fraud, or malice toward any Member or third party.

5. Decision-Making & Consent

- (a) **Deliberation:** The Assembly shall seek unity and consensus in all decisions wherever possible.
- **(b) Dissent:** Any Member who dissents from a collective decision may express their objections in the Assembly record, provided they do so with respect and in the spirit of mutual understanding.
- **(c) Amendment:** These Articles may be amended by supermajority or unanimous consent as determined by the Assembly's current practice.


6. Admission & Departure

- (a) Admission: The Assembly accepts Members based on their voluntary assent to this Covenant and acknowledgment of the Assembly's foundational documents.
- **(b) Departure:** Any Member may depart of their own free will, provided they fulfill any outstanding obligations to the Assembly and return any entrusted resources or property.
- **(c) Ongoing Duty:** Former Members remain bound to honor the privacy and dignity of the Assembly and its remaining Members.

7. Remedies & Dispute Resolution

- **(a) Internal Resolution:** The Assembly shall establish a process for mediating and resolving disputes among Members, avoiding external authorities unless absolutely necessary.
- **(b) Good Faith:** All parties to a dispute must engage in the process with sincere intent, honesty, and in pursuit of peaceful remedy.
