

CHILD PROTECTIVE SERVICES DECLARATION

For Members of the "Shield of Souls" Assembly

Declaration and Notice of Denouncement of Authority

We, the undersigned Assembly Members of the Shield of Souls, hereby formally denounce and rebut the purported authority and jurisdiction of any entity known as Child Protective Services (CPS) or its agents, officers, or affiliates. CPS is part of the corporate construct of the United States and/or federal government, entities which are, in our understanding and conviction, outside our private structure and assembly. As such, CPS holds no authority, jurisdiction, or power over our members, our families, or our lives. They are subordinate to their club and have no lawful standing within our Assembly or among living souls who claim and know their unalienable rights.

Cease and Desist: No Voluntary Engagement or Consent

We hereby make it unequivocally clear that we do not contract with, nor consent to the presence, questioning, or interference of CPS or related agencies in our private affairs. Any accidental, apparent, or mistaken implication of consent—whether through words or actions—does not constitute actual consent. All rights are reserved, waiving none, even under potential misrepresentation or lack of legal sophistication. Members unfamiliar with specific legal or procedural traps remain protected by this Declaration.

Challenges to CPS Legitimacy and Practices

It is further noted that CPS agents often operate without actual or sufficient evidence, or are deployed as tools for harassment against those unaware of their basic rights. We stand informed and resolute; attempts to use CPS as a weapon for personal vendettas or bureaucratic overreach will be met with immediate and uncompromising opposition.

Let it also be stated: under their own statutory scheme, CPS cannot lawfully remove children from families unless all other remedies have first been honestly and exhaustively pursued—a threshold that is virtually never met. Any action contrary to this is both unlawful and actionable.

Fee Schedule and Notice of Tacit Agreement

This Declaration serves as a complimentary and initial warning. Any further attempted engagement, communication, or physical presence by CPS agents or their associates with any member of the Shield of Souls

Assembly will accrue fees as follows:

\$1,000.00 (One Thousand Dollars) per each attempt or instance of contact with any member.

\$1,000.00 (One Thousand Dollars) per every 30-minute interval of continued interaction, presence, or engagement thereafter.

These fees are cumulative, non-negotiable, and are deemed accepted by any continued interaction after this notice. All fees are immediately payable to the Shield of Souls Assembly and will be used expressly for litigation and the pursuit of maximum legal remedy against individuals and entities involved.

Remedies and Actions Available to Members

In the event of violation of this Declaration, the Shield of Souls and its members reserve the right to:

Initiate Freedom of Information Act (FOIA) Requests:

Demand comprehensive disclosure by CPS regarding agents, funding, and actions, to uncover procedural misconduct, fraud, or financial abuse.

File Legal Complaints:

Litigate to the highest extent under the U.S. Constitution, invoking natural law and reserving the right to pursue charges of crimes against humanity for egregious violations.

Invoke Bonds and Liability:

File claims against the personal and professional bonds of all involved agents, supervisors, and connected parties responsible for unlawful or unauthorized acts.

Convene a Grand Jury Within the Assembly:

Convene an internal grand jury of assembly members to document, record, and adjudicate the violations, up to and including issuance of notices of liability and exposure of actors to the public and legal record.

Impose and Collect Administrative Fees:

Enforce this fee schedule through all available legal and commercial remedy, using all proceeds solely for the prosecution and exposure of violators.

Issue Notices of Default and Opportunity to Cure:

Serve official notices to involved parties and their superiors of intent to escalate if immediate withdrawal and cessation of interference are not observed.

Conclusion and Statement of Peace

This Declaration is your sufficient and lawful Notice; all CPS agents, officers, and their collaborators are commanded to leave the members of the Shield of Souls and their families undisturbed and in peace. Continued engagement constitutes voluntary acceptance of this fee schedule and agreement to be held personally and professionally liable to the highest extent of both man's law and natural law.
