MEMBER ENROLLMENT ACKNOWLEDGMENT (MEA)

1. Name of Assembly

We, the undersigned living souls (hereinafter "Members"), do hereby establish and constitute the "Shield of Souls" (the "Assembly"), standing firmly upon natural and divine law.

2. Definitions

- (a) "Living soul" means a man or woman endowed with inalienable rights under divine/natural law.
- (b) "Assembly" means the collective association of Members joined in peace under this Declaration.

3. Foundational Authority

This Assembly is founded upon the authority of the Supreme Creator and the inherent rights of each living soul. We recognize that all legitimate governance springs from divine/natural law, not from the statutes or edicts of any temporal government.

4. Independence from Statutory Jurisdiction

The Assembly expressly disclaims all subjection to statutes, codes, or corporate, municipal, state, or federal jurisdiction. This Assembly neither consents to nor recognizes any assumptions or impositions of such authority over its Members, deliberations, or internal documents.

5. Peaceful Assembly & Association

- (a) The right to peaceably assemble and associate, do no intentional harm, and respect the sovereignty and dignity of all Members.
- (b) The intent to resolve all disputes in good faith and exclusively through processes established by the Assembly, avoiding recourse to statutory courts.
- (c) A personal responsibility to uphold these principles and the unity of the Assembly.

6. Purposes & Principles

- (a) Uphold and defend the sacred covenant among its Members under natural/divine law.
- (b) Maintain transparency, mutual support, and privacy in all Assembly affairs.
- (c) Foster cooperation with other Assemblies or entities aligned with natural law principles.

7. Members' Rights and Duties

- (a) Membership is open to any living soul affirming these principles and is subject to the ongoing consent of the Assembly.
- (b) Each Member has the right to propose amendments to governance, participate in deliberations, and depart peacefully at will.
- (c) Members have a duty to act with honor, resolve disputes internally, and safeguard the Assembly's integrity.

8. Governance Documents

The Assembly may from time to time adopt further documents, such as a Charter, Oaths, or Procedures, provided they are consistent with this Declaration.

9. Notice and Security

This Assembly reserves the right to provide notice of its existence and activities in any manner it deems appropriate, balancing transparency with the security and privacy of the Members.

10. Oath of Membership

- (a) That I recognize, accept, and stand under the authority of the Supreme Creator and the inalienable rights endowed unto all living souls by natural and divine law;
- (b) That I do not now, nor shall I at any time, consent to be subject to statutory, legislative, corporate, municipal, state, or federal jurisdiction in matters concerning the Assembly and my association with its Members;
- (c) That I assemble here in peace and honor, with no intent to harm, injure, or defraud, and with full respect for the sovereignty, dignity, and private domain of all Members;
- (d) That I pledge to resolve all disputes with fellow Members privately, diligently, and with integrity, outside the forums of statutory courts, according to the processes established within the Assembly;
- (e) That I do solemnly swear or affirm to uphold the principles, duties, and spirit of this Declaration and any governance documents duly adopted by the Assembly, so long as I remain a Member in good standing.
