



# NOTICE OF UNLAWFUL DETAINMENT FEE SCHEDULE

This document serves as public notice of my fee schedule for unauthorized detainment, rights violations, and related impositions upon my time, property, and rights. This schedule is established under natural law, common law principles, and my inherent right to value my time and be compensated for unwarranted impositions. This fee schedule was established and published prior to any engagement and constitutes prior notice to all parties.

## SECTION 1: DEFINITIONS

1. **“Living Soul”** refers to the flesh and blood being, distinct from any legal fiction, person, or entity.
2. **“Officer”** refers to any individual claiming authority under color of law, including but not limited to police officers, sheriffs, deputies, highway patrol, and other law enforcement personnel.
3. **“Detainment”** refers to any restriction of movement or liberty, whether physical or by show of authority or intimidation.
4. **“Jurisdiction”** refers to lawful authority to exercise power, which must be established through proper evidence and not merely presumed.
5. **“Martial Law”** refers to military authority exercised over civilians, whether formally declared or de facto through military or national guard presence performing civilian law enforcement functions.
6. **“Emergency Powers”** refers to extraordinary authority claimed during declared emergencies that purport to suspend or limit normal constitutional protections.
7. **“Liquidated Damages”** refers to predetermined compensation for specific violations that are difficult to precisely quantify but have recognized value in legal precedent.



## **SECTION 2: STANDARD LAW ENFORCEMENT INTERACTION FEE SCHEDULE**

### **INITIAL CONTACT AND TIME VALUE:**

- 1. Initial Assessment Period (first 10 minutes):** No charge - reasonable inquiry time
- 2. Extended Detention (minutes 11-30):** \$150.00 flat rate
- 3. Prolonged Detention (after 30 minutes):** \$250.00 per hour, billed in 15-minute increments

### **UNLAWFUL ACTIONS AND VIOLATIONS:**

- 4. Physical Contact Without Consent:** \$2,500.00 per instance
- 5. Unlawful Search of Vehicle or Property:** \$750.00 per item searched
- 6. Demand for Identification Without Reasonable Suspicion:** \$500.00 per demand
- 7. Recording or Documenting Without Consent:** \$1,000.00 per instance
- 8. Threats or Intimidation to Compel Compliance:** \$1,500.00 per instance
- 9. Failure to Identify Officer (name/badge):** \$500.00 per officer
- 10. Failure to State Lawful Cause for Detention:** \$1,000.00 per instance

### **SEVERE VIOLATIONS:**

- 11. Vehicle Impoundment Without Lawful Cause:** \$750.00 per day plus all towing and storage fees
- 12. Arrest Without Probable Cause:** \$5,000.00 plus \$1,000.00 per hour of custody
- 13. Booking/Processing Fee:** \$7,500.00 flat fee
- 14. Reputation Harm from Public Detention:** \$15,000.00
- 15. Emotional Distress:** \$1,500.00 per hour of detention
- 16. Lost Opportunity Costs:** Actual documented losses plus 50%
- 17. Biological Sampling Without Consent:** \$35,000.00 per instance



## SECTION 3: MARTIAL LAW/EMERGENCY POWERS FEE SCHEDULE

### BASIC INTERACTIONS:

1. **Initial Contact Assessment (first 10 minutes):** \$500.00 flat rate
2. **Extended Detention (after 10 minutes):** \$500.00 per hour, billed in 15-minute increments
3. **Failure to Produce Emergency Declaration:** \$1,000.00 per instance
4. **Failure to Identify Chain of Command:** \$1,500.00 per instance
5. **Refusal to Acknowledge Constitutional Limitations:** \$2,000.00 per instance

### SEVERE VIOLATIONS:

6. **Home Entry Without Warrant or Consent:** \$10,000.00 per unauthorized entry
7. **Quartering of Personnel:** \$5,000.00 per day for forced housing of government agents
8. **Restriction of Movement/Confinement:** \$2,500.00 per day of unlawful confinement
9. **Property Seizure:** Replacement value plus \$5,000.00 per item
10. **Medical Autonomy Violation:** \$50,000.00 per attempted forced medical procedure
11. **Communication Interference:** \$1,000.00 per hour of communication disruption
12. **Assembly Disruption:** \$5,000.00 per instance of peaceful assembly disruption
13. **Religious Practice Interference:** \$7,500.00 per instance of religious practice restriction
14. **Forced Evacuation from Dwelling:** \$15,000.00 per instance
15. **Interference with Access to Food, Water, or Essential Supplies:** \$10,000.00 per day

## SECTION 4: STRATEGIC IMPLEMENTATION LANGUAGE

**The following statement may be used during an interaction to provide verbal notice of this fee schedule:**

"Officer, I want to inform you that my time is valuable. I have a published fee schedule on record that values my time at \$250 per hour when detained without established jurisdiction or identified injured party. This schedule was established before our interaction and applies to all unwarranted detentions. The schedule begins at the time of initial detention and continues until I am released. By continuing this detention after this notice, you acknowledge awareness of these terms. I'm documenting that this detention began at [specific time]."



## **ESCALATION STATEMENTS FOR EMERGENCY/MARTIAL LAW SCENARIOS:**

When frontline personnel refuse to engage with fundamental questions about authority and constitutional rights during emergency scenarios, the following escalation statements may be employed:

### **1. Command Structure Identification:**

"I need to speak with your commanding officer immediately regarding a constitutional rights violation in progress."

"Please identify your direct supervisor and their contact information for my records."

### **2. Habeas Corpus Invocation:**

"I am formally invoking my right to habeas corpus proceedings to challenge the lawfulness of this detention."

"Under Article I, Section 9 of the Constitution, habeas corpus can only be suspended in cases of rebellion or invasion. I demand judicial review of this detention."

### **3. Notice of Intent:**

"I'm providing notice that I'll be filing an emergency injunction with the federal district court regarding these actions."

"Be advised that I'm documenting this interaction for immediate submission to the state attorney general's civil rights division."



## SECTION 5: TERMS AND CONDITIONS

**1. NOTICE AND ACKNOWLEDGMENT:** This fee schedule has been properly filed with the County Recorder's Office, published according to legal requirements, and notice has been provided to relevant agencies. Continuation of any interaction after being informed of this fee schedule constitutes acknowledgment of these terms.

**2. BILLING AND COLLECTION:** An invoice will be presented within 30 days of any qualifying incident. Payment is due within 30 days of invoice receipt. After 30 days, interest accrues at 1.5% per month on unpaid balances.

**3. DISPUTE RESOLUTION:** Any disputes regarding this fee schedule shall be resolved through the Shield of Souls Assembly's Dispute Resolution Procedure, which both parties agree to honor as binding.

**4. RECORDING:** All interactions may be recorded for documentation purposes. Interference with recording constitutes acceptance of the aggrieved party's account of events.

**5. WAIVER:** These fees may be waived at the sole discretion of the living soul if the interaction is conducted with respect, proper jurisdiction is established, and constitutional rights are honored.

**6. INDEMNIFICATION:** By engaging with the living soul after notice of this fee schedule, officers and officials agree to personally indemnify said living soul for all listed fees if their agency refuses payment.

**7. CURRENCY:** All amounts are denominated in lawful money of account or equivalent value.

**8. SEVERABILITY:** If any portion of this fee schedule is ruled unenforceable, all other portions remain in full effect.



## SECTION 6: HISTORICAL AND LEGAL BASIS

The rates established in this fee schedule are based on the following historical and legal precedents:

### 1. PROFESSIONAL RATE PRECEDENTS:

- Attorney hourly rates (\$250-500/hour) recognized in court for wrongful detentions
- Expert witness fees (\$200-400/hour) accepted in court proceedings
- Professional consultant rates (\$150-350/hour) for specialized knowledge

### 2. COURT-AWARDED COMPENSATION:

- False arrest settlements typically award \$1,000-3,000 per hour of wrongful detention
- Civil rights violations involving detentions typically settle at \$2,000-5,000 for short detentions
- Federal Tort Claims Act cases have established values around \$250-500 per hour

### 3. DOCUMENTED PRIVATE SETTLEMENTS:

- Agencies have settled claims based on fee schedules in the range of \$150-300 per hour
- Private membership associations report settlements averaging \$250 per hour for members

### 4. CASE LAW SUPPORTING FEE SCHEDULE CONCEPTS:

- **Thompson v. Whitman (1873)** - Established that jurisdiction can always be challenged and must be proven, not presumed
- **Chicago Motor Coach v. Chicago (1929)** - "The use of highways for purposes of travel and transportation is not a mere privilege, but a common and fundamental right"
- **Bivens v. Six Unknown Named Agents (1971)** - Created pathway for constitutional claims against federal officials
- **Brown v. Texas (1979)** - Police cannot demand identification without reasonable suspicion
- **Delaware v. Prouse (1979)** - Random stops to check identification are unconstitutional
