Strict Limits Written into Every Protocol:

The Assembly has no power to use tribute, resources, or settlements for anything but the support and functioning of our group or to remedy harms done collectively to members. All policies, claims, and compensation (such as demanding redress from an agency that wrongfully targeted a member) are processed through assembly-held trusts, with proceeds remaining within the assembly’s financial and ethical boundaries.

Members’ Ultimate Oversight:

Members themselves approve, review, and may challenge any use of tribute. Transparency is mandatory; thorough internal record-keeping is required, and every member holds the right to audit how tribute has been spent. Any member can bring concerns or call for a review whenever misuse is suspected.
